4. No member who is a candidate or whose family member is a candidate, for a post to which appointment is to be made, shall take part in the proceedings of the Selection Board for selection of a candidate on such post.
5. In selection of candidates for the post of Professor or Associate Professor, the Selection Board shall co-opt or consult three experts in the subject concerned and in selecting candidates for any other teaching post, two experts in the subject concerned, to be nominated by the Vice Chancellor from a standing list of experts for each subject approved by the Board on the recommendation of the Selection Board.
6. The Board may revise the standing list of experts of a subject on the recommendation of the Selection Board.
7. **Functions of the Selection Board. – The Selection Board shall:**
 - a. Consider the applications and recommend to the Board, the names of suitable candidates for appointment to teaching and other posts and recommend suitable salary for the selected candidate.
 - b. Consider all cases of promotion or selection of officers of the University and recommend the names of suitable candidates for such promotion or selection to the Board.
